Pursuant to Advertisement No. 03/2025 dated 14.06.2025 and the subsequent notification dated 02.09.2025, it is hereby notified for the information of all concerned candidates, who are eligible and provisionally eligible for direct recruitment to the post of **Junior Stenographer** [(Level-4) pay scale in the pay matrix Rs.25500-81100], that the Objective Type Written Examination (OT-WT), to be conducted in OMR-based mode, has been scheduled as follows:

All concerned candidates are advised to carefully read the Important Note and ensure their presence at the allotted Examination Centre, mentioned on the Admit Card, on the scheduled date and time:

1. The applicants listed in the **Appendix** attached herewith (searchable by application number) are provisionally permitted to appear in the written examination.
2. **The Objective Type Written Examination (OT-WT) based on MCQ-OMR shall be conducted in Delhi.**
3. Admit cards and detailed instructions for the written examination shall be issued in due course. **Admit cards and valid ID proof are mandatory for entry.** The name and address of the allotted Examination Centre, along with the reporting time and other necessary instructions, shall be specified in the Admit Card. Candidates are, therefore, advised to make necessary travel and accommodation arrangements well in advance.
4. Further, the mere issuance of an admit card or appearance at the examination shall not confer any right upon a candidate to claim appointment to the post, or to automatically proceed to any subsequent stage of the recruitment process. Additionally, consideration for subsequent recruitment stages remains subject to the verification of all documents, certificates, and claims by the competent authorities.
5. The candidature of a candidate shall be liable to be rejected/cancelled at any stage of the recruitment process, including after the declaration of results, if he/she is found ineligible with reference to the prescribed eligibility conditions as on the cutoff date, or if any information furnished in the application is found to be false, incorrect, misleading, or based on forged/fabricated documents. In such cases, appropriate action, as deemed fit under the applicable rules, may also be initiated.
6. Candidates must report to the designated centers mentioned on the Admit cards as per the above schedule.
7. No request for change of examination city shall be entertained under any circumstances.
